Subject: - Instructions regarding depositing of Electricity Bills through RTGS.

The Himachal Pradesh State Electricity Board Limited is pleased to provide the facility to the Industrial consumers in H.P. to deposit their Electricity Bills through RTGS mode, in addition to existing mode of payments by Cheque, Draft and Cash, The following instructions are required to be observed in this regard: -

- 1. The above system is applicable only for Industrial Consumers.
- 2. The Consumers concerned depositing the energy bills through RTGS will be required to produce the printed confirmation slip of successful transfer of payment to the concerned Sub Divisions of HPSEB Ltd. showing the particulars therein i.e. Consumer Name, Consumer Account No., Date of deposit, Amount etc. immediately, latest by next working day enabling the Sub Divisions concerned to account for the receipt of energy charges payments in the accounts books and entry in the consumer ledger.
- 3. The charges, if any, levied by the bank shall be borne by the consumer.
- 4. No printed receipt will be issued by Sub Divisions against payment made through RTGS.
- 5. The due amount shall be remitted by the Industrial consumers in the HPSEB Ltd. bank account being operated at Shimla, in the respective bank, with which the concerned Sub Division is operating the collection account (List Attached).
- 6. The entry of the remittance shall be taken in the remittance register through transfer entry order before posting in the concerned ledger. However, no entry will appear in Sub Divisional Cash Book
- 7. All the Sub Divisions will prepare and supply the separate date wise schedule of remittance made through e-banking system (RTGS System) to F&A Wing, alongwith monthly account every month so that the same is monitored accordingly. The entry should be taken in monthly remittance schedule under proper bank head in which the remittance has been made.

You are, therefore, requested to bring the above cited instructions to the notice of all the field units under your control for strict compliance immediately. Any query in this regard may be taken up with Sr. Accounts Officer (Banking), HPSEB Ltd, F&A Wing, Shimla.
