The Government of Himachal Pradesh vide Principal Secretary (Power) notification No. MPP-F (10)-17/2012 dated 4th March 2014 has reduced the existing rates of electricity duty in respect of different categories of industrial consumers *(except Cement Industries)* with effect from 1st April 2014. The relevant extract of the notification is reproduced hereunder: -

7.	New Industry including EHT category which employ more than 300 Himachalis	As above	2% for 5 years
